






## PNG CIVIL AND IDENTITY REGISTRY

The Papua New Guinea Civil and Identity Registry (PNGCIR) is mandated and empowered by its own act: the **Civil Registration Act 1963 Amended 2014** to record and maintain registers of Vital Events:

- 1) Births;
- 2) Marriages;
- 3) Adoptions;
- 4) Divorces;
- Legitimation; and Deaths

PNGCIR Welcomes you into the world with a Birth Certificate,
Legalizes your Adoptions with a second Birth Certificate for Adoption. Celebrates your Marriage with a Marriage Certificate.
And Finally Farewells you with a Death Certificate.

All of which are **Archived** in **PNG's National Data Bank-PNGCIR Archives**.

# Managing Identity: Past, Present & Future

The Overarching aim of PNGCIR is to achieve a complete Civil Registration System for the country that can provide:

- All members of public with foundation identity documents through which they can claim their civil and human rights, including access to services.
- 2. The government with individual identification records needed for governance; and
- 3. The government with a national source of vital statistics .







The birth of any child born in PNG must be recorded and issued with a Birth Certificate as governed by Civil Registration Act 1963. Amended 2014.

Birth Registra-

**Civil Registration** 

- Persons below 18 years of age register their birth only.
- Persons 18 years of age and over register for both their birth and National Identity Document (NID).

# A Birth Certificate is a LEGAL IDENTITY DOCUMENT. ALL PNG Citizens must register for a BIRTH CERTIFICATE!

Without a legal identity, You are not recognized by the government, which results in being unprotected, unaccounted and alienated from government services.

To Meet the 2021 Targets; PNGCIR has deployed Mobile Teams throughout PNG with the help of District MP's who have signed MOUs.

## **MARRIAGE**



PNGCIR officiates and registers **Only** Civil Marriages through Marriage Celebrants, the Registrar General or persons appointed by the Registrar General.

**A Marriage Celebrant** is a licensed person under the Marriage Act 1963 (Chapter 280) who can legally solemnise a marriage ceremony. PNGCIR registers and certifies Marriage Celebrants from different Churches.

**Divorce** is also registered by PNGCIR, however only through a court of Law can a dissolution of marriage take place. PNGCIR registers your Divorce.

# **ADOPTION**



PNGCIR registers Adoptions in PNG. Adoption of Children Act 1968 and Civil Registration Act 1963 Section 51 give prominence to PNGCIR to register all adoption: Customary, Civil and Overseas adoption.

#### Adoption:

Change in the parents of a child legally.

Why Adopt? To give a child a home.

#### Types of Adoption:

- 1. Customary Adoption: applies to Papua New Guineans Only. Parents must obtain order from the District Court before adoption registration, many parents think handing over a child from birth to a relative is legal adoption but it is not, they must make it legal through welfare and the court.
- Civil/State Adoption: This applies to mixed marriages, foreigners and nationals. The adoption order must be obtained from National Court before they register the adoption with PNGCIR.

## **LEGITIMATION**



Subject to Civil Registration Act 1963, Marriage Act 1963, a Legitimate child either foreign or local and Illegitimate child whether foreign born or local born must and can be registered. Legitimate child is a child born before marriage and illegitimate child is a child born out of a defector relationship and/or raised by a single parent.

# **DEATH**



Death Registration is an official recording of the end of a Peron's life—Their Death and Cause of Death (COD). A death that occur within PNG boarders must be registered with the PNGCIR Office, pursuant to the Civil Registration Act 1963 Section 34,35 & 36.

PNGCIR register Death and Issue Death Certificate in PNG.

#### WHY IS IT IMPORTANT TO REGISTER A DEATH?

- Legal proof of document Death Certificate
- Inheritance/Settling Estate/Transfer of Property, Land Title
- Claiming life Insurance
- Settlement of Pension Claims
- Getting Married (proof previous partner has passed)
- Arranging for a funeral
- Identify cause of death and procure treatment for other patients
- Collect population statistics

# National Identity—NID



National Identity is an important legal Identity Document that recognizes you as a PNG Citizen before the law and the State of PNG. Persons above 18 years of age must be registered with an NID. NID registration collects your Personal Information plus your biometrics; Face photo and 10 fingers finger print. The output is a legal Birth Certificate and National Identity Card.

PNGCIR Registered: 1.3 million Persons (as of 31/12/2019)

#### **Health Planning**



- Identifying priorities maternal and child health care, Noncommunicable diseases.
- Targeting health Programs populations at risk
- Service Delivery distribution of health infrastructure, e.g. drugs, service providers and other resources

#### **Government Services**



- Education allocation of resources; schools and teachers
- Social security i.e. age of retirement and pension, Police protection and social welfare
- Infrastructure planning determining needs such as housing






## THE NID PROCESS

Registrations are done using mobile registration kits and fixed PNGCIR office throughout the country and are uploaded or are done in fixed offices (in provinces and districts) as live data uploads. The data entry follows after the registration process where vetting is done at the same time. After this, the approval process commences where there is a return to data entry if documents do not fulfill certain requirements. The data is sent to data management for a queuing process in printing before it is issued to the public and archived at the end of the process.

**Registrations** are undertaken in 17 provinces and 5 districts in the country. In Port Moresby it is undertaken at Moale Haus and Vision City (Car Park basement Floor).

**Issuance** of Birth Certificates and NID Cards are at NID Haus in Port Moresby and are sent to all fixed offices.



## NID PROJECT ROLLOUT

Knowing the actual number of people living in a district should be the priority of the provincial and district administration. To give your people a Legal Identity and for your administration to know how and where to allocate resources and plan/deliver accordingly .

# **ARCHIVES—PNG NATIONAL DATA BANK**

Archiving and safe keeping of the records and the original hard copies of all Vital Events Registration is paramount and a function of PNGCIR.

The Archives of Papua New Guinea is a National Treasure House of Information belonging to the People of PNG, with earliest records dating back to **1892**.

### **PNGCIR Archives Record and Maintain Registers of:**

- Birth,
- Marriage,
- Adoption &
- Death.



### The Archives perform 2 functions:

- 1. **Record and archive** registrations of all Vital Events daily.
- Search and Retrieve records/registers of Vital Events whenever a client request. (Requests come from the Court both National and International).


